Competition Rules

The Queensland Recreational Fishing Rules & bag limits are to be complied with at all times.

No traps allowed, a trap is a canister trap, collapsible trap, dilly trap, funnel trap, opera house or round trap.

Fish may only be caught using, a fishing line which is an apparatus consisting of a hand held line with or without a pole, reel or rod.

Junior Entrant is under 16 years of age on the date of the Competition, Proof may be required to collect Prizes.

A person must not use more than Two (2) fishing lines or set lines alone or in combination, anyone using a setline must not be more than 50 metres from the line.

Fishing will commence **07.00AM Saturday 21st March 2009**

Fishing will cease at **12.00 Noon Sunday 22nd March 2009.**

Fishing is allowed in Lake Fred Tritton **“ONLY”**.

Fish must be **alive and LEGAL LENGTH** to be weighed in.

Fish can only be weighed in during **Weigh station hours, they must be alive & legal size**, weigh station hours will be;

- **Saturday, 9.00am to 11.30am, 1.30pm to 2.30pm, 4.00pm to 5.30pm & 7.30pm to 8.30pm.**
- **Sunday, 7.30am to 8.30am, 10.30am to 12.00pm.**

Prizes will be awarded to the heaviest fish in each category.

Dispute Resolution:

The organising committee will resolve all disputes and their decision is **“FINAL”**

Mosquito Activity:

Participants are advised that precautions against Mosquito bite should be taken and these include wearing insect repellent and baggy light coloured clothes. **Mosquitos usually bite at night from sunset to sunrise.**
